The Board of Education Members and Administrators discussed in detail this system with the Safety Committee Members. The Board of Education Members agreed this system would add to the safety of our students and staff. They also agreed to have the purchase of this system as an Action Item at the February 28, 2017, Board of Education meeting.
