The Regular Meeting resumed at 8:46 PM.

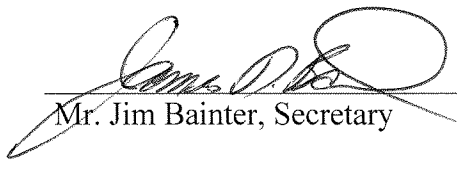
