They individually shared with the Board of Education Members why they supported the Health Insurance Committee's recommendation of the Health Insurance Benefits Plan for Fiscal Year 2017.

Mr. Vollmer along with the Board of Education Members explained to the audience members present why they are in favor in supporting the Administration's Recommendation of a different Health Insurance Benefit Plan that was more cost effective for the school district. They explained the plan recommended by the Administration is the best plan financially for district. They also shared they appreciate the hard work and time the teachers devote to Limestone Community High School, but at the end of the day they have to do what is best for the district and will support a health insurance plan that has an increase of cost to the district of 10.27% versus the purposed plan of a 19.50%.

Mr. Winkler made a motion, seconded by Mr. Neal to Approve the Limestone Community High School Employee Health Insurance Benefits Plan for the Fiscal Year 2017 with United Health Care Plan "Option 3" PPOJY3MOD8.
